

Affidavit of the Right of Suffrage

I, toni-lynn: Chester, the undersigned, am one of We the People on the land of McIntosh County, Oklahoma, and I am one of the free, sovereign, and independent American nationals on the land jurisdiction (Treaty of Paris 1783) and do hereby Affirm and state as follows:

1. I hereby rescind all of the former voter registrations inter alia which I have formerly filed because that document violated my rights to remain as the Master of my affairs, which constitutes fraud against me. It also required me to claim that I am a citizen of the United States of America or a U.S. citizen to which I am not.
2. I am of lawful age of 53 years and I am competent to make this Affirmation.
3. I was born on Worcester County, of the Massachusetts Commonwealth the 28th day of August in the year of 1963.
4. I have an abode at 118358 S. 4130 Road, Eufaula, Oklahoma [74432], where I **temporarily dwell**.
5. I have the Qualifications required by Article 1, Section 2 in the Constitution for the united States of America (1787), in Pennsylvania, and am one of the Electors in my respective county.
6. I have read and studied the Constitution for the united States of America, the Bill Of Rights, the original intent of the Constitution for the united States of America as well as the Federalist Papers, particularly Federalist 52. Therefore I have the requisite knowledge required in these Fundamental Documents.
7. This Declaration by Affidavit is made for the purpose of giving the Supervisor of Elections "Carol Hayes" and all other Electors, information for the McIntosh County Record, sufficient to show that the undersigned is a competent Elector, and designated as one of the whole number at Article 1, Section 2, Clause 2 and 3 in the Constitution for the united States of America (1787), in Pennsylvania.
8. My Christian name is toni-lynn of the Chester Family.
9. WARNING ————— My name is not TONI LYNN (all upper case) nor CHESTER (all upper case) nor any other ens legis name created as a fictitious name. Do not write or type my name on any document, paper form or otherwise in the upper case method! You shall, when writing my name, only use the proper English spelling as Toni Lynn Chester! (upper and lower case)
10. There is no delegated authority for the Oklahoma Legislature or United States Congress to regulate the Right of Suffrage for the people, therefore as an Elector there are no laws or statutes that regulate my right to vote or run for office. (see Article I, Section 2 of the Constitution for the united States of America and Federalist 52 in the Federalist Papers.)
11. I hereby rescind all political party affiliations, and I do not wish to have any political affiliations including "independent" attached to my name.
12. I do not intend to vote for any Presidential Candidate. I will only vote for the Electors who will choose the President as is mandated in the Constitution for the united States of America at Article II, Section 1, Clause 2.

I further demand that the Electors who will choose our next President of these United States names be placed on the Ballot, so I can make my choice without Party control of those Electors, and that I shall be privileged to see that no Elector is holding an office of trust or profit as enumerated in Article II, Clause 2 in the Constitution for the united States of America.

13. The above is formal notice of rescission and surrender of voter status as well as of U.S. [c]itizenship, and the adhesion contract to which it created. I further declare my Right of Suffrage as one of the people.
14. This Notice and Demand and WARNING is being delivered to Oklahoma Secretary of State, Oklahoma County, Oklahoma on this 25th day of April 2017 by toni-lynn: Chester to Dave Lopez at Oklahoma County, Oklahoma, Secretary of State Office at S.O.S address Colcord Center 421 NW 13th Street, Suite 210/220, Oklahoma City, Oklahoma near [73103],
