

Fee Schedule for toni-lynn:chester, Sovereign, non-citizen National, Natural Born Woman, Living Free Upon the Land

Pertaining to traffic stops, and/or any other forms of arrest, unlawful detainment, or imprescriptible rights violations.

3. If I am a recipient of any Constitutional Protections violations, the fee will be \$250,000 per crime, per individual, per day, provided there is no violence, and this includes unlawful jail / prison time / restriction on my Liberty, Rights or Freedom. This fee is non-negotiable, meaning cannot be changed by discussion, not subject to negotiation.
4. If I receive any broken bones via unlawful violence, the fee will be \$1,000,000 per broken bone, plus full remedy / reimbursement for all medical expenses, plus 100,000 per day throughout the duration of the healing process. This amount will be multiplied by the number of violators involved. This fee is non-negotiable, meaning cannot be changed by discussion, not subject to negotiation.
5. If I bleed from any unlawfully obtained injuries, the fee will be \$1,000,000 per injury, plus full remedy / reimbursement for all medical expenses, plus 100,000 per day throughout the duration of the healing process. This amount will be multiplied by the number of violators involved. This fee is non-negotiable, meaning cannot be changed by discussion, not subject to negotiation.
6. If I am bruised, scraped, disheveled, caused pain from any unlawful action, the fee will be 100,000 per injury, plus full remedy / reimbursement for all medical expenses, plus 10,000 per day during the healing process. This amount will be multiplied by the number of violators involved. This fee is non-negotiable, meaning cannot be changed by discussion, not subject to negotiation.
7. If I receive nerve damage or injury via unlawful violence, the fee will be \$1,000,000 per injury, plus full remedy / reimbursement for all medical expenses, plus 100,000 per day throughout the duration of the healing process or the duration of my life for permanent injuries. This amount will be multiplied by the number of violators involved. This fee is non-negotiable, meaning cannot be changed by discussion, not subject to negotiation.
8. If I receive spinal injuries or mobility injuries via unlawful violence, the fee will be \$10,000,000 per injury, plus full remedy / reimbursement for all medical expenses, plus 500,000 per day throughout the duration of the healing process or the duration of my life for permanent injuries. This amount will be multiplied by the number of violators involved. This fee is non-negotiable, meaning cannot be changed by discussion, not subject to negotiation.
9. If I receive joint injuries via unlawful violence, the fee will be \$5,000,000 per injury, plus full remedy / reimbursement for all medical expenses, plus 250,000 per day throughout the duration of the healing process or the duration of my life for permanent injuries. This amount will be multiplied by the number of violators involved. This fee is non-negotiable, meaning cannot be changed by discussion, not subject to negotiation.
10. If I receive head injuries or soft tissue injuries via unlawful violence, the fee will be \$10,000,000 per injury, plus full remedy / reimbursement for all medical expenses, plus 500,000 per day throughout the duration of the healing process or the duration of my life for permanent injuries. This amount will be multiplied by the number of violators involved. This fee is non-negotiable, meaning cannot be changed by discussion, not subject to negotiation.
11. If I receive injuries resulting in dismemberment or amputation, not causing death, via unlawful violence, the fee will be \$50,000,000 per injury, plus full remedy / reimbursement for all medical expenses, plus 1,000,000 per day throughout the duration of the healing process or the duration of my life for permanent injuries. This amount will be multiplied by the

number of violators involved. This fee is non-negotiable, meaning cannot be changed by discussion, not subject to negotiation.

12. If I receive injuries causing loss of vision via unlawful violence, the fee will be \$10,000,000 per injury, plus full remedy / reimbursement for all medical expenses, plus 500,000 per day throughout the duration of the healing process or the duration of my life for permanent injuries. This amount will be multiplied by the number of violators involved. This fee is non-negotiable, meaning cannot be changed by discussion, not subject to negotiation.

13. If my property is damaged, stolen, destroyed, removed via unlawful action, the fee will be \$100,000 plus full replacement cost of the property, plus 25,000 per day property is out of my possession or deemed unusable. This amount will be multiplied by the number of violators involved. This fee is non-negotiable, meaning cannot be changed by discussion, not subject to negotiation.

14. If I am tased, the fee will be \$1,000,000 per tase, as they are known to have caused injuries, as well as fatalities, plus full remedy / reimbursement for all medical expenses, plus 100,000 per day throughout the duration of the healing process. This amount will be multiplied by the number of violators involved. This fee is non-negotiable, meaning cannot be changed by discussion, not subject to negotiation.

15. If I die because of unlawful injuries, the fee will be \$1,000,000,000, to be awarded to my mother, father, brother and son. This amount will be multiplied by the number of violators involved. This fee is non-negotiable, meaning cannot be changed by discussion, not subject to negotiation.

I, toni-lynn:chester, have an imprescriptible right, granted by the Divine Creator, to uninterrupted freedom of travel by the common mode of the day, without any form of license, and/or other unjustified, unlawful forms of taxation and/or restrictions. The right to travel is one of the unalienable rights not specifically mentioned in the Bill of Rights. I am not a Driver, therefor I do not need a Driver's License. I am a lawful "Traveler", moving from point A to point B, and I have a right to travel freely upon the land, water, or in the air, anywhere upon the planet.
