The State of Nevada, to any Peace Officer in the County of Clark. Proof by Affidavit having been made before me by KENNETH MEAD, P# 5831, said Affidavit attached hereto and incorporated herein by reference, that there is probable cause to believe that certain property, namely

- 6) **Banking records, statements, financial documents related to the BATANGYAGIT FOUNDATION or addressed to 9030 West Sahara #617, Las Vegas, NV, 89117,**
- 7) **Adult persons located in the home during the time of service,**

8) Any vehicles parked within the curtilage of the residence to include inside the garage and front driveway

9) Any adults persons on the property at the time of service


and limited items of personal property which would tend to establish a possessory interest in the items seized pursuant to this search warrant, such as personal identification, photographs, utility receipts or addressed envelopes, are presently located at **1300 Mount Augusta Ct, Las Vegas, NV 89117. 1300 Mount Augusta Ct is described as a two story, west facing single family residence. The home can be described as off white in color with a red tile roof. The numbers 1300 are just to the left when facing the garage door and are black numbers on a white illuminated background. The off white garage door faces west and has 8 small windows in the upper portion of the garage door. The front door is beige in color and faces west. There is a covered entry way to the front door and a large tree and landscape rock are in the front yard. The home is located just south of a grass and concrete walking path through the development.**

And as I am satisfied that there is probable cause to believe that said property is located as set forth above and that based upon the affidavit attached hereto there are sufficient grounds for the issuance of the Search Warrant.


**ORDER SEALING
