A Public Declaration and Notice

Notice of Affidavit in Truth, And Affidavit in Truth

1. I, Dominick Guarneri, hereinafter affiant, a living, sentient, fleshly creation, as one of the People of California, a sovereign political power holder, and a free inhabitant domiciled at San Diego county within the geographic boundaries of the California Republic/ state, do hereby declare within this Affidavit in Truth, and do herein Notice and assert the following averments.
2. On or about June 23, 2016, affiant collaborated with Bruce Doucette, a Judge of Article III standing, a non-Bar Association jurist at American common law, and domiciled in the Union state of Colorado, to identify a design for a suitable and appropriately representative badge for members of the named Continental Marshals service to wear, whom would be prior qualified and certified for said positions as men and women domiciled or located in any one of the fifty Union states of America.
3. From the aforementioned collaboration between affiant and Judge Doucette that centered upon the badge design for members of the Continental Marshals service, no provision was allegedly discussed or was contemplated for the formal copyright of the badge design.
4. However, understanding was nonetheless retained by affiant and Doucette as the badge designers for their inherent and unalienable right of copyright of its design, as non-transferrable to any other unnamed or unknown parties (by dint of their potentially unilateral assertions), as though the right of copyright by said badge designers was jointly disregarded or was abandoned.
5. During July 2016, Judge Doucette issued requests for proposals (RFPs) which detailed parameters of the badge design to prospective suppliers of the badge. Potential suppliers included Vortex Engineering, Hollywood and 3D Printing (and possibly others or one other), for the purpose of enabling full scale production of the badge.
6. In late July 2016, prospective suppliers for the badge creation had responded to Doucette's RFPs with quotations for production and delivery.

7. Action pursuant to the evaluation of the aforementioned supplier bids was put on hold and delayed due to third party involvement which sought to enlarge the potential supplier base, and then alter the detail of the original badge design.

8. This third party intervention disregarded the optimization of production costs and savings, and thus invalidated the earlier bids from the above named would-be suppliers.


9. Responsibility to pursue the acquisition of badges was then handed-off to a third party, which action subsequently noticed the compromise of the design parameters earlier set by affiant and Doucette.
